



## BREEDERS' DECLARATION FORM 2014



Because many of our enquiries are received from people who know extremely little about the breed, they trust the Somali Cat Club to help them find a suitable kitten. Therefore, any breeders' names, listed on the Website or placed on the Kitten List, are seen by potential buyers as being endorsed by the Club. For this reason, before your details/kittens can be placed on the Club's Website or Kitten List, the breeder must read and agree to abide by the rules by signing the declaration below. The form should be returned to the Club Secretary for our records. A charge of £5.00 is required for a litter advert on the Kittens for Sale page of the Website.

### BREEDER'S DECLARATION

I/we wish to be placed on the Somali Cat Club Breeder/Kitten List and agree to abide by the following rules. I/we accept that the Somali Cat Club reserves the right to refuse the inclusion of any of my/our details or kittens bred by me/us on the Club Website or Kitten List if I/we have been found to be in breach of any of the following rules or the club has received a complaint that is proven:

1. I/we agree to abide by the GCCF Code of Ethics, included with this document.
2. All kittens will have completed their primary vaccination course.
3. No kitten will leave the breeder's premises under the age of thirteen weeks.
4. No kitten will knowingly be sold on the Active Register for breeding if it has a fault that precludes it from being shown (e.g. umbilical hernia, tail fault, or other faults listed in the Somali Standard of Points).
5. The experience of prospective owners will be taken into careful consideration before a male kitten is sold as a potential stud (three years' breeding experience advised).
6. No queen under normal circumstances is to have more than two litters a year.
7. All purchasers will be provided with the relevant paperwork and a signed pedigree as required by the GCCF Rules on collection of their kitten.
8. All purchasers will be provided with a membership form for the Somali Cat Club.
9. This service is for fully paid up members only; those members who do not maintain their annual subscription and listing fee will be removed from the website.
